- 1. **Approval of Agenda (Kohn).** Motion to approve the agenda as drafted (Diehl). 2<sup>nd</sup> (Unterriker) Approved 10-0.
- 2. **USA Lacrosse Updates (Burke)** (1) Membership platform has changed and now includes (a) roster verification tool for program administrators (b) e-learning platform (c) coaching education modules. (2) Will be shifting to a coaching education model similar to USA Hockey. (3) USA Lacrosse will no longer host Laxcon. For 2023, there will be a "mini convention" in Indianapolis called the Lacrosse Academy. Dates are Oct. 7-9, 2023. Open to coaches, officials, trainers, etc.
- 3. **Minutes from 07/09/2023 (Unterriker).** Motion to accept the 07/09/23 minutes as drafted (Unterriker). 2<sup>nd</sup> (Kohn). Approved 10-0.
- 4. **Financial Report (Miller).** For the time period of 7/10/23 9/10/23: (1) Income of \$100.00 for youth team dues and \$4632.28 for state tournament revenue. (2) Expenses of \$65.99 for bank services and \$11,900.70 for state tournament expenses. Cash balance on 9/10/23 is \$50,427.01.
- 5. **Director's and Conference Reports** 
  - a. WIAA (Fleming) (1) WIAA was not expecting that new conferences would be formed for the 2024 season. Understanding was that nothing would change for year 1. Nonetheless, the former Classic 8, Big Badger/Badgerland and Bay Valley high school conferences have realigned into conferences used by other sports. Former Classic 8 -> Classic 8, Greater Metro, North Shore and a new conference TBD. Former Big Badger/Badgerland -> Badger, Big 8. Former Bay Valley -> Fox Valley, Fox River Classic. Hudson and Superior will be independent. (2) The deadline for teams to request a conference realignment for lacrosse is Oct. 1.
  - b. Officials (Wollin) (1) Had a meeting with YOTA and the LOAs to discuss direction moving forward. Will stick to the status quo for recruiting and training officials/umpires.
    (2) Would like to see fall and winter training. (3) Board discussed access for assignors to WIAA website and officials' registration for lacrosse on the WIAA website.

  - e. **Coaches (Diehl)** (1) Will begin looking into forming coaches' associations for boys and girls lacrosse. Coaches associations for baseball, football, golf, hockey, softball,

swimming, tennis, and wrestling are officially incorporated entities registered with the DFI. (2) ADs are responsible for communicating WIAA contact rules to coaches.

- h. **Youth (Anderson)** (1) Currently 12 U14 A boys teams interested in a statewide league with games on Saturdays and a state tournament.
- i. **Bay Valley (Thomson)** (1) Held board elections. (2) Shifting focus toward youth. (3) Discussed the U14 A boys league. (4) Will hold a National Celebrate Lacrosse event on 11/11/23 at Pulaski Middle School.
